Without any frustration, they assisted me in getting back on track. I received a comprehensive description of what task they wanted me to work on. It was difficult at first, but I eventually understood everything. They also gave me their email addresses in case I needed assistance. Everyone in the group was considerate of one's space. My target audience includes minorities, POC (People of Color) in poverty, and government officials. I related with them because I am a person of color. By presenting rational facts about how and what solar, wind, and hydro technologies will aid. The most crucial aspect of how they will improve climate change is that funds must be provided to develop these technologies if we are to protect the future.Pathos was used to raise awareness about how people of color in poverty face greater challenges than others. This helps others to put themselves in their shoes and comprehend how hard it is to live in such situations, but with the dangers of catastrophic events, it leaves them with hope.It emphasizes that we should not just sit at home or dismiss it since it could happen to us one day. I would believe that these appeals have been rather successful since they allow individuals to be more considerate in order to promote awareness. It also educates people about the detrimental implications of climate change. That a small difference can make a great difference.
